

GHEA MUSIC GROUP PRIVACY POLICY

Ghea Music Group (A.B.N. 71 549 283 937) (**we, us and our**) operates an online retailing business through the website at <https://www.gheamusicgroup.com.au> (**Website**).

This Privacy Policy explains our approach to dealing with your Personal Information. We set out how we collect, hold, manage and use Personal Information, including when you visit, interact with or use our Website.

We may update our Privacy Policy from time to time by posting a new version on our Website and it will be binding on you and us from the date it is posted on our Website.

Scope of Policy

1. This Privacy Policy applies to all Personal Information we hold.
2. "Personal Information" under the *Privacy Act 1988* (Cth) is defined to mean information or an opinion (including information or an opinion forming part of a database), whether true or not, and whether recorded in a material form or not, about an individual whose identity is apparent, or can reasonably be ascertained, from the information or opinion.

Your Consent

3. By using our Website and accessing our goods and services, you consent to us using any Personal Information that we collect for any of the purposes set out in this Privacy Policy.

Collection of Personal Information

Why do we collect Personal Information?

4. We collect and hold Personal Information that is reasonably necessary for the services we provide.

How do we collect Personal Information?

5. We will generally collect Personal Information from you directly through your use of our Website including when you visit, access, place an order or use other services provided on our Website.
6. We may also collect Personal Information through applications, email or written communication with you, or through a telephone conversation with you.

What form of Personal Information do we collect?

7. We may collect and hold the following types of Personal Information:
 - (a) Your name;
 - (b) Your date of birth;
 - (c) Your phone number;
 - (d) Your email address;
 - (e) Your mailing address and delivery address;
 - (f) Payment details;
 - (g) Information provided by you when you use or request other services available on our Website; and
8. If you choose to correspond with us through email, we may retain the content of your email messages together with your email address and our responses. We provide the same protections for these electronic communications that we employ in the maintenance of information received by mail and telephone.

How we use your Personal Information

9. We collect, use and disclose Personal Information for purposes associated with conducting our business activities, providing the goods and services you requested, marketing and promotional efforts and to improve our content and service offerings, including:
 - (a) Facilitating transactions between you and us;
 - (b) Facilitating transactions between you and other people, suppliers and organisations who are accessible via our Website, for example when you hire musicians and bands via our Website;
 - (c) Processing your payment for goods and services;
 - (d) Tracking your orders;
 - (e) Monitoring the use of our Website;
 - (f) Improving the quality of our service;
 - (g) Administrative purposes;
 - (h) Statistical analysis of the usage of our Website; and
 - (i) Complying with the law, including privacy legislation.
10. Occasionally, we may also use the Personal Information we collect to notify you about important changes to our Website, new services, and special offers we think you will find valuable. You may notify us at any time if you do not wish to receive these offers by emailing us at the link provided on notifications or by contacting us at: info@gheamusicgroup.com.au

Direct Marketing

11. If you have given us your express consent to:
 - (a) Provide you with direct marketing communications; or
 - (b) Provide your Personal Information to third party individuals and organisations who offer goods and services on our Website (for example, musicians and bands)

we may collect, hold, use and disclose Personal Information in accordance with that consent to enable us (or as the case may be those third party individuals and organisations) to provide you information about, and offer you, goods and services.
12. If you give us consent to provide you with direct marketing communications, you can later request not to receive direct marketing communications. You may also request that we do not provide your Personal Information to any of our third party providers in order for them to provide you with direct marketing communications.

Disclosure

13. Such information may be shared with others as de-identified data in aggregated form.
14. Personally identifiable information or business information will not be shared with third parties except as required by law or where you have given us your express consent to do so.
15. We may need to provide your Personal Information to third parties who we engage to assist us to provide goods and services to you, such as:
 - (a) Delivery agents;
 - (b) Information technology service providers; and
 - (c) Payment processors.
16. Where your Personal Information is disclosed to these third parties, they will only be authorised to use your Personal Information for the purpose that we supplied it to them. If those third parties are located overseas, then your Personal Information may be transferred overseas.

Cookies and Website Data Activity

17. We may use standard technology called 'cookies' on our Website. Cookies are small data files that are stored on your computer when you visit a particular website, which allow your web browser to remember certain information.
18. By using our Website, you agree to our use of cookies and our Website will issue cookies as soon as you visit our Website. You may disable cookies by turning them off in your browser, however some functions of our Website will not be available to you if you do this.
19. Sometimes information that you upload is provided with associated metadata. If you do not want us to use the metadata you must remove it before uploading it onto our Website and other applications and tools.
20. We may collect data that is associated with your visit, including the pages you visit, the activities you do and the purchases you make etc. We may also collect information relating to the computer, mobile phone or other device including the device type, the browser, location, IP address and search words used. We may collect, use and disclose and store this information in any of the ways set out in this Privacy Policy.

Data Security and Storage

21. Personal Information collected by us will be stored and processed on servers located within Australia. To prevent unauthorised access, maintain data accuracy, and ensure the correct use of information, we have put in place appropriate physical, electronic, and managerial procedures to safeguard and secure the information we collect online.
22. In limited circumstances, we may need to send your Personal Information overseas, including but not limited to the United States of America, South Africa and parts of Europe. These circumstances include:
 - (a) Where we have a supplier assisting us with the provision of goods and services and our business functions; and
 - (b) Where a third party application is being used in connection with our interactions with you (e.g. for processing of payments or security checks).
23. We will take all reasonable steps to maintain the security of Personal Information in these circumstances in accordance with this Privacy Policy, but our ability to ultimately control where these third party providers host their applications or process their data may be limited.

Links to other Websites and Applications

24. Our Website may contain links to other websites, applications and tools that are owned, controlled or operated by us. We are not responsible for the practices employed by websites linked to or from our Website or the information or content contained on them.
25. Please remember that when you use a link to go from our Website to another website, our Privacy Policy is no longer in effect. Your browsing and interaction on any other website, including websites that have a link on our Website, is subject to that website's own rules and policies. Please read over those rules and policies before proceeding.

Legal Disclosure of Personal Information

26. We reserve the right to disclose any Personal Information which identifies you as required by law and when we believe that disclosure is necessary to protect our rights, or to comply with a judicial proceeding, court order, or legal process served on our Website.

How to Opt-out or Access your Personal Information

27. If you:

- (a) Want to find out what Personal Information we hold about you;
- (b) Believe any of your Personal Information held by us is inaccurate, out of date, incomplete or it is not necessary for us to continue to hold it;
- (c) Want to request not to receive direct marketing communications or that we do not provide your Personal Information to any of our third party providers in order for them to provide you with direct marketing communications; or
- (d) Wish to make a complaint about a breach of the Privacy Act, Australian Privacy Principles or a privacy code that applies to us,
